### **Cost Estimate for Surrogacy**

#### The Surrogacy Program

- *Estimate Only. Costs may change depending upon your specific surrogate's circumstances. Experienced Surrogates receive an additional \$5,000.00 fee per successful delivery*

Surrogate Fee (1 <sup>st</sup> time Surrogate)	\$25,000.00
IVF Transfer Fee Per Cycle ( <i>assumes one cycle</i> )	\$1,000.00
Cycling Allowance ( <i>per IVF cycle- assumes 1 cycle</i> )	\$400.00
Pregnancy Allowance ( <i>8 months at \$200 per month</i> )	\$1,600.00
Maternity Clothing Allowance	\$500.00
Life Insurance	\$500.00-\$600.00
Meeting Allowance ( <i>5 meetings at \$100 per meeting</i> )	\$500.00

### Other Potential Costs for Surrogacy

- *Insurance for Surrogates can be costly. A private Llyod's of London policy can cost \$25,000.00 for a singleton. Other options may be available.*
- *There is a possibility of a lien on some insurance policies for maternity costs. If your surrogate has one of these policies it will be required to place \$10,000 in your Escrow Account to cover this lien.*
